Are you ready for more from your dental and vision plans? ORNL is rolling out basic and enhanced options that offer fantastic new benefits!



Enhanced Dental Plan: Get more coverage, including adult orthodontia, so you can smile with confidence!



Enhanced Vision Plan: Enjoy a higher allowance for frames and contacts—seeing clearly and looking stylish just got easier!

Open Enrollment is here! Don't miss your chance to choose the best plans for you and your family. Plus, it's the perfect time to set your Health Savings Account (HSA) contributions for 2025.

Check out the details and how to enroll to make the most of these new benefits!

Good news! In 2025, you can contribute more to your Health Savings Account.

For individual coverage levels, the maximum contribution will be \$4,300. For all other coverage levels, the maximum contribution will be \$8,550. (These limits include the employer contribution, which will be \$500 for individual coverage and \$1,000 for all other coverage levels.) If you are 55 or older, you will be allowed to contribute an additional \$1,000.

Reminder: You must reelect your HSA contributions each year.

The IRS has increased the minimum deductible allowed under a high-deductible health plan for 2025. For individual coverage, the in-network deductible will be \$1,650; all other coverage levels will be \$3,300. The in-network out-of-pocket maximum will remain \$2,500 for individual coverage and \$5,000 for all other coverage levels.

To complete Open Enrollment, log in to your ADP account at <https://my.adp.com> or call 1-800-211-3622. If you encounter account issues or your account is locked, you must call ADP. ADP phone hours are Monday through Friday, 8 a.m.–8 p.m., and Saturday, 8 a.m.–5 p.m. (EST).

Vision

ORNL will offer a basic and enhanced vision plan to employees through Vision Service Plan (VSP). For employees currently enrolled in the Consumer Choice plan, your enrollment will default to the Consumer Choice Basic Vision Plan. Your medical plan premium will continue to be a combined premium for medical, prescription, and vision benefits.

Highlights of the Enhanced Vision Plan:

- Increased frame allowance to \$200 every year
- Increased contact lens allowance to \$200 every year
- **VSP Light Care:** Frame and lens allowances can be used toward nonprescription sunglasses or nonprescription blue-light-filtering glasses

If you earned the wellness incentive for 2025, then deduct \$7.93* from the weekly premiums shown above. (*\$420 wellness incentive divided by 53 pay periods in 2025).

Dental

Your dental plan options are changing. ORNL is changing to one dental plan provider, Delta Dental. Employees will have a choice between a basic and enhanced dental plan. If you are currently enrolled in a dental plan, then your enrollment will default to the Delta Dental Basic Plan.

Highlights of the Enhanced Dental Plan:

- No per-person deductible
- Increased lifetime orthodontia maximum up to \$3,000
- Adult orthodontia
- Increased calendar year maximum to \$3,000
