

**SUMMARY ANNUAL REPORT FOR
OAK RIDGE NATIONAL LABORATORIES FRINGE BENEFIT WRAP PLAN**

This is a summary of the annual report of the OAK RIDGE NATIONAL LABORATORIES FRINGE BENEFIT PLAN, a life insurance, temporary disability, prepaid legal, long-term disability, severance pay and death benefits plan (Employer Identification Number 62-1788235, Plan Number 511) for the plan year 01/01/2021 through 12/31/2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

UT-BATTELLE, LLC has committed itself to pay certain claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with METROPOLITAN LIFE INSURANCE COMPANY, ARAG INSURANCE COMPANY and ZURICH AMERICAN INSURANCE COMPANY to pay certain life insurance, legal insurance, accidental death and dismemberment, business travel, special accident claims incurred under the terms of the plan. The total premium paid for the plan year ending 12/31/2021 were \$10,543,587.

Because they are so called "experience rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2021, the premiums paid under such "experience-rated" contracts were \$7,597,136 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$4,943,819.
